What we do

The Responding to Hate Incidents in North Somerset (RHINS) multi-agency partnership group was established in 2002 and leads the implementation of the North Somerset Hate Crime strategy.

The purpose of RHINS is to:

- promote collaborative working between local agencies, support organisations and members of the community involved with hate incidents in North Somerset.
- achieve consistency of approach and effective resolution of hate incidents across partner agencies.
- identify any hate crime issues using available partnership data and to collaborate and use the resources of all partners to tackle identified
- raise awareness of and improve confidence in the reporting procedure as well as unblock any blockages in reporting
- give support and guidance on the development of partner policies and procedures that relate to hate incidents or the promotion of equality, diversity and community cohesion.

Our achievements in 2021/22

Hate Crime Awareness Week 2021 - The RHINS partnership organised another successful Hate Crime Awareness Week which saw various awareness raising activities across North Somerset. These activities not only raised awareness of hate crime and how it report, they also celebrated diversity in North Somerset.

Expansion of RHINS Partership – The RHINS partnership group has continued to expand with local agencies, voluntary sector and community groups. This has enabled good joined up working across these organisation to coordinate our response to Hate Crime and share good practice to ensure offenders are brought to justice and victims are supported.

SARI has been recommssioned – Stand Against Racism and Inequlity (SARI) have been recommissioned by the Big Lottery Funding, bringing specialist hate crime support services for North Somerset.

Upskilling Police in responding to hate - Local Neighbourhood Policing Teams and Response Police have received training on hate crime and ensuring all victims are offered support.
