### The North Somerset Community Safety Partnership

The Community Safety Partnership will provide senior strategic oversight of crime and disorder reduction. This includes:

- the assessment of prevalence of crime and need for local services
- development, review and monitoring of Safer Communities Plan.
- determine how resources are allocated from the Police and Crime Grant
- reviewing the effectiveness of local initiatives to address crime and disorder including monitoring crime statistics and performance information
- provide strategic governance and oversight for multi-agency projects and programmes which support the Partnerships' objectives
- provide a response to applications for review under the Anti-Social-Behaviour, Crime and Policing Act 2014 (sometimes referred to as the Community Trigger)
- to appoint panels to undertake Domestic Homicide Reviews

## Our achievements against priorities in the last year

#### **Building strong resilient communities**

- A new partnership <u>Prevent</u> plan developed in line with the Counter Terrorism Profile
- Six vulnerable individuals at risk of being drawn into terrorism managed through the Channel process
- Enhanced our response to <u>Anti-Social Behaviour</u> by introducing new PSPOs across North Somerset, managing of 17 community trigger applications by victims of ASB and finalising of new ASB processes and procedures

#### <u>Tackling crime types and locations where there are particular concerns</u>

- <u>Violence Reduction Unit (VRU)</u> launched a crime &violence consultation with secondary schools & college to explore demand/concerns - to steer commissioning & priorities
- Trauma informed training delivered to police officers and other key partnership officers
- Secured over £480k of Violence Reduction Funding over the next 3 years
- Commissioning of new Violence Reduction interventions and new projects to intervene early and divert young people from crime.
- The finalising of our <u>CCTV Control Room</u> upgrade creating a digital network of cameras fixed and mobile across North Somerset.
- Successful procurement of Deployable Cameras (following successful bid for Safer Streets Funding). Cameras are 'unique' within the industry.
- Renewing of Purple Flag in WSM town centre evidencing a safe, vibrant well managed Evening & Night-time Economy

#### **Supporting vulnerable victims**

- Implementation of the <u>Domestic Abuse</u> Act 2021 duties including creation of the new Domestic Abuse Strategy 2020-23.
- Successful bid for £375K to Home Office for <u>safer streets funding</u> to launch an
  innovative project with Somerset to improve safety in public places for women
  and girls.
